Form section 6: Exemption questions, notice of compliance instructions, and owner signature lines.

Form section 7: Personal property included in selling price, exemption details, and tax calculation table showing a total due of 10.00.

Form section 8: Signature lines for Grantor's Agent (STEVEN BIEGERT) and Grantee's Agent (GLORIA BIEGERT) with dates and cities.

Perjury: Perjury is a class C felony which is punishable by imprisonment in the state correctional institution for a maximum term of not more than five years, or by a fine in an amount fixed by the court of not more than five thousand dollars (\$5,000.00), or by both imprisonment and fine (RCW 9A.20.020 (1C)).
